I acknowledge and agree that by participating in a Villa Vita tour, expedition, or vacation, I am doing so willingly and of my own volition.

I acknowledge that I have voluntarily applied to **Villa Vita** and that **Villa Vita** relies in part on others to provide transportation, personal excursions, accommodations, balloon flights, bicycle or scooter rentals, and instructions.

I further acknowledge and agree to accept any and all risks of delay, unanticipated events, illness, injury, emotional trauma or death and agree to release absolve, indemnify and hold harmless **Villa Vita** its organizers, sponsors, shareholders, representatives and employees from any injury or loss caused by or resulting from the accommodations, balloon flight, cycling, scooters, cooking demonstrations or employment of any and all independent contractors.

## Terms and Conditions

### **Reservations:**

**Our Programs:** A deposit of \$250 per person is required to secure your reservation. To secure reservations on a trip departing within 90 days, a full payment is required by credit card at the time of booking. All amounts are stated in United States dollars.

Final payment for all departures must be received in full by Villa Vita at least 90 days prior to departure, unless otherwise stated. Reservations will be cancelled if final payment is not received by the due date and cancellation charges will apply. Tour prices stated are per person and based on double occupancy. Airfare, Departure Taxes, surcharges, and government fees are not part of the tour price and are the sole responsibility of the passenger.

**Changes in plans:** For changes you make to your reservation from 120-90 days prior to departure that affect the arrival city, accommodations and/or passport name changes, a \$50 per-person administrative charge applies. Changes to departure date or destination from 90-46 days prior to departure may incur cancellation fees.

We regret that we cannot accept changes to reservations within 45 days of departure. All changes are subject to availability and cannot be guaranteed.

Every effort has been made to produce pricing information accurately. We reserve the right to correct errors.

### **Cancellations and Refunds:**

If you must cancel your trip, you must do so in writing. Cancellation refunds will be calculated as of the date we receive your written cancellation.

All payments for travel services not provided to the passenger shall be refunded in accordance with these Terms and Conditions and in accordance with Villa Vita's cancellation policy.

**Processing Fee:** There is a non-refundable fee of \$250 per person for each program you cancel. This fee reflects only our costs of administering a reservation, and is not intended to be punitive in any way. We realize the majority of those who cancel their reservations do so out of necessity.

Any applicable refunds will be processed 30 days after our receipt of your written cancellation.

**Cancellation Charges for Our Tours:** Unless otherwise stated, for all cancellations we will refund the cost of your trip less the following per-person charges. Charges shown include the \$250 administrative fee:

#### **Prior to departure: Charge**

45 days or more: \$250 per person

44 -0 days: 100% of selling price per person

### **Passports:**

A valid passport is required for U.S. citizens traveling on our international programs. You will be notified if your destination requires a visa for U.S. Citizens. Non-U.S. citizens should contact the appropriate consular office for entry requirements pertaining to their trip, as Villa Vita International is not responsible for providing you with this information or documentation.

## **Air Travel Arrangements:**

Villa Vita International can provide assistance with flight arrangements and is not be responsible for any loss resulting from cancellations or changes in international gateways or travel dates. We recommend that you do not purchase tickets with high penalty charges for changes.

## **Single Travelers:**

All of our accommodations are based on double occupancy. A single occupancy supplement will apply when a double room is occupied by a single guest.

Roommate matching: Whenever possible, Villa Vita International will offer a share program. If you would like to share a twin-bedded room with another single traveler of the same gender, we will do our best to match you with a roommate. We will charge you only 50% of the single supplement; if you share accommodations, we will refund the single supplement after you return.

## **Limited Responsibility of Villa Vita:**

The responsibility of Villa Vita Inc. d.b.a. Villa Vita International and its affiliated companies is strictly limited. As a tour operator, Villa Vita International organizes, promotes, and sells tour programs consisting of certain travel services, including surface, air, and water transportation, sightseeing excursions, and cruise/hotel accommodations that Villa Vita International purchases or reserves from various suppliers (collectively, "Suppliers"). Villa Vita International does not own or operate any of these Suppliers. The Suppliers providing travel services for Villa Vita's tour programs are independent contractors, and are not agents or employees of Villa Vita. As such, Villa Vita International is not responsible for any negligent or willful act or failure to act of any supplier or of any third party. Some tours include visits to shops and merchants. Villa Vita International is not responsible for any purchases you make during your trip, whether that merchant is part of the scheduled itinerary or not. By utilizing the travel services of the Suppliers, you agree that you will look to such Suppliers for any accident, injury, property damage, or personal loss to you or to those traveling with you, and that neither Villa Vita international nor any representative of Villa Vita International shall be liable.

Without limitation, Villa Vita International is not responsible for any injury, loss, or damage to person or property, death, delay, or inconvenience in connection with the provision of, or failure to provide, any goods or services occasioned by or resulting from--but not limited to--acts of God or force of nature, acts of war or civil unrest, insurrection or revolt, strikes or other labor activities, criminal or terrorist activities of any kind, overbooking or downgrading of accommodations, mechanical or other failure of airplanes or other means of transportation or for the failure of any transportation mechanism to arrive or depart on time, sanitation problems, lack of medical care, or for any other cause beyond the direct control of Villa Vita International.

Villa Vita International reserves the right to correct promotional or pricing errors at any time, or to increase the program price in the event of cost increases due to changes in currency fluctuations, park fee increases, taxes, or surcharges. Villa Vita International reserves the right to decline to accept or retain any person as a member of any tour or to cancel or alter the tour without notice, in which event your sole remedy shall be a prorated refund for any unused portion of the trip. Hotels and other accommodations are subject to change.

Villa Vita International reserves the right to change the departure date of any trip, as well as cancel any trip or extension that does not reach a minimal level of participation. If Villa Vita International changes a departure date to another departure date that departs within 14 days from the original departure, cancellation penalties as described in this document still apply should you subsequently decide to cancel. If Villa Vita International cancels any optional extension for which you are booked, cancellation penalties as described in this document still apply should you subsequently decide to cancel the base (main) portion of your trip.

Villa Vita International, like most tour operators may overbook its vacations. We do this because historically, a few people cancel their trips when they book with us. Overbooking is done in the best interest of our customers and Villa Vita Incorporated. With the revenue produced by filling spots on our trips that would otherwise go empty, we maintain exceptional value on our trips. This allows us to accept more reservations than decline them when customers call to make a booking. This does not necessarily mean that if you have a reservation you will not be accommodated on your trip.

If between 90 and 7 days or more prior to your departure, more customers are confirmed than can be accommodated, a Villa Vita representative will contact volunteers who are willing to give up their places in exchange for compensation and a confirmed spot on a future departure date. On rare occasions, customers may be involuntarily moved to another departure date if a sufficient number of volunteers are not obtained. We may take into consideration at that time factors such as date booked, fare paid and severe hardships. With few exceptions, passengers denied their trips involuntarily are entitled to compensation.

California law requires certain sellers of travel to have a trust account or bond. This business is not a participant in the California Travel Consumer Restitution Corporation.

### **Medical Issues:**

You must advise us in writing, at or prior to booking, of any physical, emotional or mental condition that may require professional attention during the trip or may require the use of special equipment. If you fail to disclose any such conditions, Villa Vita International may refuse to allow you to take the trip and you will forfeit the trip cost; and in such event we shall have no liability, financial or otherwise.

If you are so challenged, you must bring and be responsible for all necessary items related to your condition. If any such condition arises after the trip [s booked, you must advise us in writing immediately. Failure to advise us shall release Villa Vita International and all professional personnel from any liability related to such condition or its treatment.

We cannot accommodate women past their sixth month of pregnancy. If you require a wheelchair, you must provide your own small, collapsible wheelchair. Certain features, and certain trips, are not wheelchair-accessible. We cannot guarantee any wheelchair assistance or accessibility in international destinations. Villa Vita International reserves the right to decline any trip participant whose condition, in our opinion, may affect the health, safety or enjoyment of other participants,

Villa Vita International is not responsible for the costs of any medical treatment you may require during the trip. Under no circumstances is Villa Vita International responsible for the quality of medical care, or lack thereof, you may receive while on the trip.
